Vietnam Business Climate Outlook 2010/2011

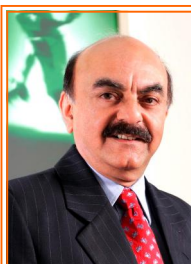
Mr. Gregory F. Buhyoff - Of Counsel, Hogan Lovells LLP
